

Approval of an Agreement between GPCID and Jackson EMC

Upon the recommendation of Mr. Allen and following confirmation that Mr. Rainey had reviewed the contract, Mr. Wheeler motioned to authorize the Executive Director to execute an agreement between GPCID and Jackson EMC for the installation of banners; seconded by Mr. Coffey and unanimously approved.

Approval of Agreement between GPCID and the Gwinnett County Board of Commissioners for Construction of Sidewalks

Upon the recommendation of Mr. Allen, Mr. Wheeler motioned approval for the Chairman to execute an agreement between GPCID and the Gwinnett County Board of Commissioners to proceed with the construction of 1,800 linear feet of sidewalks and 8 ADA ramps along Old Norcross Road from the Pleasant Hill Road intersection to the Acura Carland property for a base amount not to exceed \$40,000.00; seconded by Mr. Coffey and unanimously approved. With this expenditure, the balance of the CID's funding of \$167,000 allocated to the CID from SPLOST funds in 2006 is now exhausted.

October 15, 2007 Legislative Luncheon Fund Expenditure Approval

Upon the recommendation of Mr. Allen, Mr. Coffey motioned to authorize the Executive Director to expend funds necessary to co-host with the other Gwinnett County CIDs the October 15, 2007 Legislative Luncheon for members of the Gwinnett County Legislative Delegation for a base amount not to exceed \$1,675.00; seconded by Mr. Wiener and unanimously approved.
